Every column and line on this page must be filled by the Recorder with the appropriate information so far as given by the deed, and one horizontal line must be devoted to every separate parcel of land described in the deed, except in deeds conveying several lots, designated by numbers or letters, all in the same block, similarly designated, when all such lots, if space permits, shall be shown on the same line; and in the proper column there must be shown the whole number of separate parcels of land described in the deed.
